3. Submitted a current officiating schedule showing at least 10 Varsity games
4. Have a 2.7, 2.5, 2.1 3 year average to work District/Regional, Quarterfinal/Semifinal, Final respectively
5. For Finals, not have worked a finals in the last 3 years

**The MMOA requires:**

1. Current membership
2. Active status in the current directory (member in good standing)

Failure to participate in MMOA training activities **WILL** influence Post Season Recommendation

To apply for recommendation by the MMOA to the MHSAA for tournament assignments, please:

1. Attach a photocopy of the rating data card you received from MHSAA
2. Attach a photocopy of the schedule of games you submitted to the MHSAA (If you do not have a copy of your schedule, write it on the back of this form).

Evidence of falsification of data on this application will result in the application being refused for this year and the next.
